* Report from the president
$>$ Karen opens the conference. She has served two years as president of NPA but wishes to step down now.

Report from the secretary-treasurer
$>$ In the absence of Lars Peterson, Anna Arnadottir presented the Financial Report (see Appendix A).
$>$ Two years ago the account was slightly in the negative, but then the membership fees came in. There was some activity on the accounts as Hotel refunds were paid after the Lubeck conference and when NPA awarded five travel grants for the 2023 conference and four of those were claimed.
> The status of the NPA account is now 2795 DKK
$>$ Voting members approved the financial report by more than a 2/3 majority.

Updates to the NPA bylaws
$>$ Based on discussions at the last NPA member meeting updates have been made to the NPA Bylaws. The two main changes are the introduction of the position of General Manager and the position(s) of Advisor to the board.
> There was some discussions about if more countries should be included as member countries (Faroe Island, Greenland, Poland). This will be looked at by the board and potentially implemented in the next update to the NPA bylaws.
$>$ Voting members approved the updates to the NPA bylaws by more than a $2 / 3$ majority.

Election of the new NPA board members
$>$ The election committee presented a suggestion for the composition of the board for the next two years (attached as Appendix B)
> Voting members approved the board composition as suggested by the election committee by more than a $2 / 3$ majority.

NPA 2025 conference
$>$ Üllar Kivila, newly elected NPA president, presented a bid from the AHHAA science center in Tartu, Estonia, for the NPA 2025 conference.
